1. Introduction

1.1. Purpose and requirements

Technical information about the implementation is presented at this section as well.




Figure 1 Project purpose page






Figure 2 Project funding page




Figure 3 Part of the consortium page




Figure 4 News & events sample page




Figure 5 Publications page

A contact form will be available for everyone to be able to share his/hers thoughts or to send an inquiry to project's managers. The contact form is linked to the email address of Project Coordinator.






Figure 6 The contact form

3.3. Press Announcement, Invitations and Brochures


